

## ALL BOATS PARTICPATING IN MCYS EVENTS MUST HAVE VALID INSURANCE AND CURRENT DECLARATION\*

## **DECLARATION OF INSURANCE COVER**

MCYS as a part of its duty of care to the public and its members requires that each boat participating in MCYS events shall have a **minimum of \$10,000,000 third party liability insurance cover.** 

This Declaration of Insurance Cover must be lodged annually with the Secretary MCYS. All owners who participate in MCYS events must have made a declaration that they hold such insurance cover. Failure to do so will result in boats not being able to participate in MCYS events.

I declare and confirm that the insurance I have meets the minimum requirements as stated above and I shall maintain such cover for the 2022/2023 MCYS Squadron Year. Further, I indemnify Martha Cove Yacht Squadron Inc., its employees, officials and volunteers against any cost incurred in the event that my insurance cover does not meet these minimum requirements or does not cover any loss incurred howsoever during any MCYS event in which the boat participates.
