MEMORANDUM ATTACHED TO THE 2024 NOTICE OF AGM

SPECIAL RESOLUTION FOR ALTERATION of the CONSTITUTION

Currently, the only members entitled to vote at an AGM pursuant to clause 8.18.1 are "voting members" as defined in the constitution.

The General Committee has determined that "Spouse or Partner" members making up a Family Membership should also be entitled to vote.

NOTICE is given of a proposed special Resolution to amend to the Constitution to give the "spouse or partner" of a senior member who is part of a Family Membership under 4.6.2. voting rights.

To bring this about, the constitution needs to be altered. The Constitution provides:

21.3 Alteration

This constitution may only be altered by special resolution at a General Meeting.

Currently, a Family Membership is defined in the Constitution as:

4.6.2 Family Membership

(a) A Family Membership consists of one (1) Senior Member and one (1) Affiliate (Spouse or Partner) Member;

Voting Members (those members who have a vote at the AGM are defined as:

9.6.2 Voting Members

Only Members of the following classes of Membership have a voting right under 9.1(a) and (b) hereof:

- (a) Life Members;
- (b) Senior Members;
- (c) Intermediate Members.

There is an error by way of a misdescription in the Constitution – where the reference to clauses 9.1(a) and (b) in clause 9.6.2 is incorrect. Those clauses do not exist, and the reference should be to clause 8.18.1 which effectively defines who may vote, namely "Voting Members".

There is also an error by way of misdescription in Clause 8.18.1 where it refers to "...under clause 11 hereof". Clause 11 is all about the Treasurer. The reference should be to clause 9.6.2.

To clean up these errors by way of misdescriptions, and to amend the constitution so that a "spouse or partner" in a Family Membership has a vote, the following needs to be done:

- 1. Alter by way of amendment to clause 8.18.1 so that the reference to clause 11 therein is amended to be a reference to clause 9.6.2; and
- 2. Alter by way of amendment to clause 9.6.2 so that the reference to clause 9.1 (a) and (b) is amended to be a reference to clause 8.18.1; and
- 3. Alter by way of amendment to clause 9.6.2 by adding after sub-clause (c), the following:
 - d. The spouse or partner of a Senior member in a Family Membership as defined in this Constitution.

The end result is that the "spouse or partner" in a Family Membership will also have the right to vote.
